## **PEI Provincial Council CWL Subsidy Guidelines for 2017**

The PEI Provincial Council has set up a budget of \$1500.00 with a maximum limit of \$250.00 being allotted per parish council. This would allow for six subsidies. It would be ideal for councils to come together with other councils in your area and work on projects that would help fellow members celebrate our theme "*Inspired by the Spirit, women respond to God's call*". Projects could be as simple as having guest speakers on this theme. After hearing these speakers, discussions could follow and ideas could be shared on how we can concretely celebrate this theme. The project and ideas are yours; this is only one suggestion.

- 1. Requests for funding will be evaluated on an individual basis by the PEI Provincial Council.
- 2. Requests for funding for the following purposes will be considered:
- \* To assist councils in their work on our theme "Inspired by the Spirit, women respond to God's call"

\*to assist parishes in coming together with other parish councils and come up with ideas and actions that can be taken in the area of the theme's provincial focus which is palliative care

- \* To promote League development through working together for the good of all our brothers and sisters
  - 3. When planning a workshop consideration should be given to:
  - \* The objects of the Catholic Women's League
  - \* The leadership development of the CWL members
  - 4. The following steps must be followed when applying for a subsidy:
  - \* Estimate the amount of subsidy required to effectively conduct the workshop or event
- \*Complete the application form and submit a project outline and then forward to Provincial President for approval by the PEI Provincial Council. **Submission deadline May 31, 2017** 
  - \* The Provincial Council will notify the council re their request

As soon as possible after the workshop/event, a follow up summary must be completed (including all receipts) and forwarded to Provincial Council President.

The PEI Provincial Council is responsible for ensuring that the subsidy requested is valid and reasonable.

100% funding is available within budget limitations of \$250.00

All councils are eligible to apply.
